COURSE DESCRIPTION AND PREREQUISITES

AGRI 340 Development of written and oral communication skills to address current issues in agriculture. Prerequisite: Eng 280 & Agri 220.

This course has been designated to meet the Writing Instruction in the Disciplines (WID) graduation requirement. WID courses provide instruction in the processes and formats for the writing content and style needed to be an effective professional in a student's chosen field.

- 4. Write business emails, letters, reports, blog posts, and presentations.
- 5. Feel comfortable discussing a variety of agriculture issues and help others to have a greater understanding of agriculture.

THE BASICS

Proper grammar, spelling, verb usage, flow, punctuation, capitalization, etc. should come naturally to you by now. All writing assignments will be graded for mechanics and additional errors will result in a loss of points. Assignments will also be graded on content, clarity, attention to detail and instructions, and completeness among other components.

Writing Focused Assignments

Ag Issue Opinion Piece: (25 pts) Write a brief on the biggest issue facing the agriculture industry today. If you are stating the obvious, look at it from all angles. Breathe new life into the issue.

^{**}Handwritten assignments will not be accepted and will result in 0 points. **

Email/Letter: (25/50 pts) Write a business email or letter, pending the assignment and issue at hand.

Blog Post (120 pts): Write a blog post and post it to the WIU School of Ag blog. Posts should include a title, your name as the author, relevant, pre-approved content, and photos. Your post will be read by the public. **Posts deemed inappropriate or profane will result in a failing grade.

Facebook Posts: (50 pts) Create 5 Facebook posts about agrocating for agriculture. Two shares of articles (not classmate's posts) are allowed, but you <u>must</u> include your own unique comments for the post. Three of your posts must be created using Canva.com. Summarize your experience. Was there engagement? Did people comment/like/share your post? Did you receive any negative comments? If so, how did you handle them? Screenshot each of your posts and comments and include with your write-up in a Word document.

Twitter/Instagram Posts: (50 pts) Create 5 Twitter OR Instagram posts agrocating for agriculture. Two retweets (not from classmates) are allowed, but you must include your own unique comments for the post. You must tag @WIUAg and use the hashtag #WIUAgLife. If you do not tag WIUAg AND use the hashtag, you will not receive credit for that tweet. Compile screenshots into a Word document on WO. No write up is needed.

Consumer Concern Responses: (50 pts) Respond to consumer concerns using the EASE method of communicating agriculture issues.

Ag Documentary Reflection Summary: (50 pts) After watching a documentary in class, write a reflection summary based on the questions provided and your own reaction.

Research

Source Identification: (25 pts) Identify three credible sources of information for your persuasive essay. Submit three complete MLA citations in proper format from the following types of sources: TWO peer-reviewed journal articles and an agricultural extension publication. Use the CRAAP test to help you determine credibility. These sources must be unique and not the same as your friends.

Thesis & Outline: (25 pts) Complete a working thesis and outline of your persuasive essay.

Peer Review: (25 pts) Review a draft of a paper written by a classmate. Your feedback should be constructive.

Persuasive Essay: (200 pts) Write a persuasive essay on the topic assigned. Essays should be 3-5 double spaced pages. Essays should be unbiased, include scientific information, and conclude with your argument for your stance, which should be supported by science and sound reasoning.

Food Labels: (300 pts-group assignment)

Review food labels as printed on current food packaging for your assigned commodity. Are the food labels mandated by the government? Regulated by the government? Necessary for health reasons? Truthful? Solely for marketing purposes? Design and conduct a survey of consumers to understand their preferences and what contributes to their purchasing choices. Compile your information in writing and with graphs/charts. Present your information in class.

Agriculture Advocacy Project/College Aggies Online---This is a big maybe

Plan Proposal: (50 pts) As a group, complete a project plan proposal for your agriculture outreach project in detail. Intent, dates, times, message, supplies, budget, etc. are all needed in the proposal.

Agriculture Outreach Project: (200 pts) Develop, organize, and conduct an agriculture outreach project to educate the consuming public about the truths of food and fuel production and practice communicating with people about agriculture. Messages should be effective, informative, and reach the masses.

Ag Outreach Summary: (50 pts) Complete a summary stating what you did for your project. What was the overall message? How did you convey the message? Was it effective? What would you change if you could do it differently? Include a minimum of 10 photos from your event. Due within one week after your event is held.

Quizzes: Quizzes will be given at the instructor's discretion and will be unannounced.

Final Exam: (200 pts) The comprehensive final exam will cover the material presented in class by the instructor and the group presentations. The final will be a take home exam.

Extra Credit

Daily Dirt: (10 pts) Each week we will discuss a current event/ag issue. If you provide me with the topic you wish to discuss and lead the discussion in class, you will receive 10 extra credit points. You must notify me of the topic prior to class, via email.
