COURSE DESCRIPTION: This course is designed for Agriculture majors who are interested in developing their basic understanding of genetics, along with learning about the techniques and implications of manipulating genes in plant and animal systems. With the recent advances in cloning, genetic engineering and gene editing, understanding the genetics and the current molecular technology in genetics is critical for agriculture majors dealing with concerns of genetically modified organisms. It is also critical for agriculture majors to consider and understand the social implications of manipulating genes. Students will develop a basic understanding of: Mitosis and meiosis, DNA structure and replication, RNA transcription and protein translation, principles of classical genetics, control of gene expression, DNA mutations, methods for assessing genetic diversity, recent developments in genetic technology, and social implications of manipulating genetic information in agricultural organisms. GRADING: Four quizzes will be given throughout the semester each worth 25 pts. There will also be three midterm exams after each section, each worth 100 pts and a final exam worth 200pts. Student groups will be required to present a brief genetics paper in front of the class and hand-in a 2-page summary of their presentation with references. The presentation and paper are worth 100 pts. Homework will count for 50 points, while attendance and participation in class discussions will count for 100 points.
