## HOMEWORKS:

Homeworks will focus on understanding key concepts. I strongly encourage you to work on your own before checking your answers with your classmates. Homeworks are due at the beginning of class. Late assignments will be penalized $20 \%$ and will not be accepted after they are discussed in class and/or posted on WesternOnline.

## QUIZZES:

Ten-point quizzes on lectures, readings or other references - True/false and multiple choice. Quizzes are scheduled on Fridays at $8: 40$ and other days, if necessary. There will be no makeups, no taking the quizzes early or coming to class late just to take quizzes. The lowest score quiz will be dropped. If a student has an official excused absence in writing (illness, judging team, etc.) reported before class has started, the total quiz score will be adjusted with no penalty. The instructor reserves the right to use both announced and unannounced quizzes.

## POLICY PAPER AND PRESENTATION:

Individual policy paper: Please make arrangements to meet with the instructor in the third week of the course to select a topic. The paper must be submitted on April $27^{\text {th }}$ by 11:59 p.m. via Dropbox, no exceptions. Papers must be at least 5 pages (not including the title page and the references section) and typed using Times New Roman, 12 point, doubled spaced and 1-inch margins all around.

Paper presentations: At the end of the semester students will make a 10 -minutes formal PowerPoint presentation to the class on the policy paper.

Further details about the paper and presentation will be provided in class.

## EXAMS:

There will be 2 midterms and one final exam. Exams will consist mostly of multiple choice questions along with a limited number of short answer questions and/or problem solving questions. The final exam will be comprehensive (same format as semester exams). Makeup exams will only be given in extreme situations.

## GRADING DISAGREEMENTS:

If a student disagrees with a particular answer, it is the student's responsibility to provide a logical reason in writing as to the reason for their disagreement. This does not apply to scoring errors. All instructors are human and occasional errors in grading will occur. Please bring any such errors to the instructor's attention immediately.
