COURSE DESCRIPTION AND PREREQUISITES

AGRI 340 Development of written and oral communication skills to address current issues in agriculture. Pre-Requisite: Eng 280 & Agri 220.

This course has been designated to meet the Writing Instruction in the Disciplines (WID) graduation requirement. WID courses provide instruction in the processes and formats for the writing content and style needed to be an effective professional in a student's chosen field.

The course has three main areas of focus: writing, a group research paper/presentation, and an outreach project.

- 3. Orally present information on an agricultural issue with confidence.
- 4. Write business e-mails, letters, reports, blog posts, and presentations.
- 5. Feel comfortable discussing a variety of agriculture issues and help others to have a greater understanding of agriculture.
- 6. Question everything. Ask yourself why you do things the way you do. Strive to make improvements in agriculture.

ASSIGNMENTS

Formatting: Unless otherwise noted, all assignments should be:

- typed, 12 pt. font
- 1" margins on all sides
- Times New Roman or Garamond font
- Labeled with your name, date, assignment name, and class section.
- MLA style
- All papers of one draft stapled together. Drafts should be paper clipped together.

Failure to properly format any assignment will result in a loss of 5 points.

**Handwritten assignments or unreadable will not be accepted and will result in 0 points.

THE BASICS

Proper grammar, spelling, verb usage, flow, punctuation, capitalization, etc. should come naturally to you by now.

All writing assignments will be graded for mechanics and additional errors will results in a loss of points. Assignments will also be graded on content, clarity, attention to detail and instructions, and completeness among other components.

Writing Focused Assignments

Ag Issue Opinion Piece: (30 pts) Write a brief on the biggest issue facing the agriculture industry today. If you are stating the obvious, look at it from all angles. Breathe new life into the issue.

Email: (30 pts) Write and send a professional email.

Letter: (50 pts) Write a business letter.

Blog Post (120 pts): Write a blog post and post it to the WIU School of Ag blog. Posts should include a title, your name as the author, relevant, pre-approved content, and photos. Your post will be read by the public. **Posts deemed inappropriate or profane will result in a failing grade.

Facebook Posts: (50 pts) Create 5 Facebook posts agrocating for agriculture. Simply sharing Ag trivia does not count. Two shares of articles (not classmate's posts) are allowed, but you <u>must</u> include your own unique comments for the post. Three of your posts must be created using Canva.com. Summarize your experience. Was there engagement? Did people comment/like/share your post? Did you receive any negative comments? If so, how did you handle them? Screenshot each of your posts and comments and include with your write-up in a Word document.

Twitter Posts: (50 pts) Create 5 Twitter posts agrocating for agriculture. Simply sharing Ag trivia does not count. Two retweets (not from classmates) are allowed, but you must include your own unique comments for the post. You must tag @WIUAg and use the hashtag #WIUAgLife. If you do not tag WIUAg AND use the hashtag, you will not receive credit for that tweet. Compile screenshots into a Word document on WO. No write up is needed. OR

Instagram Posts: (50 pts) Create 5 Instagram posts advocating for agriculture using Canva. Simply sharing Ag trivia does not count. You must use the hashtags #WIUAgLife, #agriculture, #agvocate

Advocacy Case Responses: (50 pts) Respond to case studies using the EASE method of communicating agriculture issues.

Ag Documentary Reflection Summary: (50 pts) After watching a documentary in class, write a reflection summary based on the questions provided and your own reaction.

Ag 340-Communicating Agricultural Issues

Group Paper/Presentation (Two parts)

Ag Issues Paper: (400 pts) As a group, write an in-depth research paper covering your assigned commodity from the beginning of production through its processing into a consumable product. Identify and discuss the issues that producers face in sustainably operating their farm, as well as the issues that concern consumers at each step of the process. Upon completion of your paper, you should be well versed about the production of that commodity as well as the truths related to the issues along the way.

Please hand in your rough draft with your final paper (one paper per group). The comments made in your drafts should be addressed in your final paper unless previously cleared with the instructor. Your paper should include:

- A cover page with paper title, names of each student in the group, class number and section, date.
- Executive summary
- Essay with MLA in-text cites
- Survey data
- Optional addendums
- Works Cited: You must use a minimum of 4 credible sources for your paper. You may <u>NOT</u> use Wikipedia as a source.

Food Labels Research & Presentation: (300 pts)

Review food labels as printed on current food packaging for your assigned commodity. Are the food labels mandated by the government? Regulated by the government? Necessary for health reasons? Truthful? Solely for marketing purposes? Conduct a survey of consumers to understand their preferences and what contributes to their purchasing choices. Compile your information in writing and with graphs/charts. Present your information in class.

Thesis & Outline: (50 pts) Complete a working thesis and outline of your final paper to help you organize your research and the flow of your paper. Additional items may be added to your final paper, however the material presented in your outline should appear in your paper. You must hand this in with your final paper.

Source Credibility Check: (25 pts) Determine the credibility of the provided sources by answering the questions provided in the library guide.

Source Identification: (10 pts) Identify two credible sources of information for your essay. Hand in two complete MLA citations.

Draft: (50 pts) Your first draft of your paper should be a minimum of two-pages long. It will be reviewed by the instructor as well as a peer in order to provide constructive feedback as you finalize your paper. You must hand in this draft with your final paper.

Peer Review: (15 pts) Review a draft of a paper written by another group. Your feedback should be constructive.

In-Class Group Presentation: (100 pts) Present your research in presentation form to the class. Answer any questions raised in an effective manner.

Quizzes: Quizzes will be given at the instructor's discretion and will be unannounced.

Final Exam: (200 pts) The comprehensive final exam will cover the material presented in class by the instructor and the group presentations.

Extra Credit

Daily Dirt: (10 pts) Each week we will discuss a current event/ag issue. If you provide me with the topic you wish to discuss and lead the discussion in class, you will receive 10 extra credit points. You must notify me of the topic prior to class, either via email or in person.

*Additional extra credit opportunities may be available throughout the semester.
