Course Description: Course presents methods for analysis of agricultural data to facilitate data-driven decision making for precision agriculture. Some topics include: map scale and projection, coordinate systems, soil nutrient maps, yield maps, interpolation and analysis methods, and creation of prescription maps.

Course Objectives:

- Identify principles of GPS including factors affecting accuracy and differential correction for GPS
- Distinguish principles of map scale and projection and coordinate systems
- Recognize methods for taking soil samples for development of soil nutrient maps
- Discriminate dataset analysis techniques like indices, principal component analysis, and cluster analysis
- Analyze ag. data using applications like Farmworks or IFARM to make sound, data-driven decisions
- Formulate standard and custom prescription maps to vary inputs according to decisions made
